### **DIRECTORS REPORT:**

John Crook gave an update on the West Louisiana Museum. Renovations are still ongoing. Grounds have been cleaned up. Furniture is being restored. Ground maintenance continues.

John Crook has drafted a letter to ask the Vernon Parish Police Jury for assistance with request from the Junior League to assist with ground prep for proposed garden.

John stated that Vernon Parish Tourism Commission will purchase 2 trash receptacles requested by the Kiwanis Club for the Nona Mills Pocket Park. Angela Broyard has spoken to Cleco on a light installation for the park. Cleco will install a dusk to dawn light and run electricity to the existing pole located in the park. Kiwanis will be required to call and make the request to install the light and electricity to the existing pole and set up an account. There will be no charge for the installation of light or hook up of electricity.

MayFest 2023 music lineup is complete, and vendors are being accepted for the event. John will visit the businesses on 3<sup>rd</sup> St. to discuss MayFest use of 3<sup>rd</sup> St. during the festival under required permit, and any effect it may have on their business.

John Crook proposed that going forward if any group wants to utilize the electricity on 3<sup>rd</sup> Street, they will need to provide Vernon Parish Tourism Commission a 30-day notice, the dates the electricity will be needed and will be responsible for the payment of all cost to have the electricity turned on, off and power used for their event.

John requested that the Executive Board meeting scheduled for March 9, 2023 be rescheduled for March 16, 2023 due to scheduling conflict with filming of promotional advertisement that will be conducted by 4WWL to Promote Leesville and Vernon Parish on this date.
