Arts & Crafts Application

Thank you for expressing an interest in an <u>ARTS & CRAFTS</u> booth space for MayFest 2024 which will be held May 3rd and 4th in Historic Downtown Leesville.

Booths must be set up and ready for business Friday, May 3^{rd} , by 3:00 pm and remain in place and open until Saturday, May 4^{th} , at 9:00 pm.

- All items <u>MUST BE HANDCRAFTED</u>. We reserve the right to expel any vendor not in compliance with this requirement and vendor will forfeit the application fee.
- ➤ Booth spaces are 10x20 feet. Fees are \$180 for 10x20. Electricity is available. Electricity will be provided for an extra fee of \$25.00. Tents, roofs, tarps, sides, chairs, tables, extension cords, or sandbags are not provided.
- Personal checks and money orders are accepted. **NO CASH** will be accepted.
- Vendors need at least 200 feet of heavy-duty extension cords. ONLY THE ELECTRICAL ITEMS LISTED AND APPROVED ON THE APPLICATION will be allowed. No direct wiring will be allowed.
- You will need to provide total Electrical Amps you will be using during the Festival. Additional electricity will not be available on the dates of the event. Failure to report all Amps that will be needed during the festival could result in electricity not being provided to you during the festival or could result in you being asked to vacate the festival. Failure to report total Amp usage could result in the disruption of other food vendors, vendors and music during the festival. Please list ALL appliances, fans, AC, etc. that you will be using to include amp usage for each. All electrical items used in a booth MUST BE LISTED IN ADVANCE on the application.
- Deadline for applications is Friday, April 28th, 2023. We reserve the right to stop accepting applications prior to the deadline.
- ➤ Booths may be set up on Friday, May 3rd, between 8:00 am and 1:00 pm. Towing vehicles will only be allowed in the festival area for 30 minutes after sign in. Parking <u>IS NOT ALLOWED</u> within any of the festival perimeters during festival hours.
- Booths must remain open on Friday, May 3rd, from 4:00 pm until 9:00 pm. On Saturday, May 4th, booths must be open from 8:00 am until 9:00 pm.
- MayFest 2024 is a rain or shine event.
- The Vernon Parish Tourism Commission will not be liable for refunds or any other liabilities whatsoever for the failure to produce MayFest 2024 due to reasons of the closure of the festival.
- All sales of food and drink for consumption on the premises by Arts & Crafts vendors are PROHIBITED. Jellies, jerky, etc. are allowed. Please call if you have any questions.
- Vendors are responsible for all taxes and fees.
- There will be no refund of registration fees for booth cancellations after April 21st, 2024.
- Insurance, if desired by vendor, must be obtained at their own expense. The Vernon Parish Tourism Commission or MayFest 2024 representatives assume no risk.


